#### What is a TCC and why are we meeting?

A TCC, or Transportation Coordination Committee, is a committee of transportation providers, planners, riders, and anyone else that may have something to do with transportation and mobility in the area. We meet quarterly to discuss transportation, mobility, and the Coordinated Transportation Plan for the area.

#### What is a Coordinated Transportation Plan?

This is a plan for our four-county area to coordinate transportation providers in order to increase mobility for folks in our area and find transportation gaps.

## **Paulding County Coordinated Transportation Plan**

We are beginning the annual update for our Coordinated Transportation Plan.

- Changed from the 6-month plan provided by ODOT to an 8-month plan to give us more time to prep
- Starting in November, we will begin evaluating past/existing projects, surveys for providers, find other providers in the area

Note that ODOT has changed from a calendar year to a state fiscal year, so updates are now due at the end of June rather than the end of November.

This plan is for 2022-2026, so the next full plan update will be June 2026.

NOTE: Paulding will be added to the Multi-County plan in June 2024

#### Notes:

- Is it possible to add Paulding County to the Multi-County coordinated plan? (Tim Copsey)
  - Yes, this can be done in 2024 or 2025 (Carly, ODOT)
  - The more counties involved in one plan, the better
  - o Plans are due June 30<sup>th</sup>
  - o Decided to include Paulding County in 2024 coordinated plan 😉
    - This means a bit more work, but we have plenty of time to start working on it!

## **Next Steps**

Transportation providers will be asked to fill out a survey to ensure all information and data is correct.

Transportation providers, riders, the public, and any other stakeholders may be asked to complete a survey and possibly interviews.

Please note that public/rider surveys may be distributed/conducted by Bowling Green State University Master of Public Administration (MPA) students beginning in January. It is essential for them as future public administrators to have relevant, real-life experiences such as this. This will be both a great experience for them along with a great asset to us, as they will help us cover more ground.

## **Community Updates**

This is the time for any updates, questions, comments, or concerns.

- Discussion of providers:
  - CareSource and other Medicaid/Medicare providers do provide transportation for those enrolled in their programs (only to/from their medical appointments?)
- 5310 funding = contracts & services
- 5311 funding = public transit
  - o Goal is to add 5311 funded public transit in our counties
  - o NEEDED: a non-profit or senior center to be the main contact/head
  - SIERRA: Reach out to Stefanie Motter with questions about moving Paulding to Multi-County, reach out to Alex from ODOT to discuss 5311, reach out to Kelsey with NOCAC to add to NOCAC website
- SIERRA: Create county-specific mobility guides on website/business cards?
- What to do about younger people needing a specialist
  - Create a long-term goal/plan for this
  - Senior center can transport if parent/guardian is older than 60
  - Meals on wheels also delivers to disabled children if parent/guardian is older than 60
- With 5311 funding, the earliest any projects would be started is July 1<sup>st</sup>, 2025
