Goals & Strategies

- Goal 1: Main funding is 5310 focuses on senior citizens and people with disabilities
 - o Strategy 1.1: Some people pay privately, but funding is trying to be found to get people to work. Sierra wants to add Paulding to the Multi-County (Defiance, Fulton, Henry, Williams) TCC plan.
- Goal 2:
 - o Strategy 2.1: Marsha has retired, and she was concerned about competition and losing
 - Have a separate meeting with Carrie, the new director
 - o 2026 is more feasible for this goal rather than 2025
- Goal 3:
 - o Strategy 3.1: Sierra starting up monthly reports in August or September
 - o All programs and providers up to date on the mobility website
 - o Attending 2 public events
 - o Senior center has hosted some events
 - o Sierra posts on Facebook almost weekly
 - o Sierra will create a LinkedIn for professionals in mobility to connect
 - o Lots of younger people on TikTok
