Executive Summary

This Coordinated Transportation Plan for Defiance, Fulton, Henry, Paulding and Williams Counties. The county plans were initially developed in 2013 for Henry County and updated in 2017. The same year, 2017, Defiance and Fulton Counties developed individual county coordinated plans. Williams County was added to the plan in 2020, and Paulding County had their own plan in 2020. This will be the first coordinated plan with all five counties.

The locally developed Coordinated Public Transit-Human Services Transportation Plan must be updated to reflect new programs and rules for funding and authorize transit programs for five (5) years.

Transportation is a critical component of the communities in the region. Transportation provides access to jobs, education, healthcare, human services and allows all community members, including older adults, people with disabilities and low-income, to live independently and engage in community life. It is the purpose of this plan to outline existing transportation resources in the region, understand where gaps and unmet needs exist within those resources, then determine a strategy for how to address those needs and gaps in services.

There is a need for coordination of transportation services in the region, as there is no fixed-route public transit service that currently exists. In 2020, Maumee Valley Planning Organization, under the guidance of the Mobility Manager, organized county meetings to discuss collaborating with the coordinated plan efforts. In March of 2021, the first Multi-County Transportation Coordination Committee (TCC) meeting was held. The goal of the committee was to lay out a plan and timeline for the creation of a coordinated plan. In January of 2024, the first Five-County Transportation Coordination Committee (TCC) meeting was held. The goal of the new five-county committee remains the same. Entering a five-county coordinated plan will allow conversation among local service organizations and community members about solutions to transportation challenges. Leading to coordination of existing transportation services to increase cost efficiencies and expand services for residents in the region, especially senior citizens, individuals with a disability and low-income individuals.

The development of this coordinated plan is the result of a year of TCC meetings, research into the specific needs of the region, feedback gathered from residents and existing transportation service providers and other local stakeholders.

1. COMMUNITY RESOURCES

Several organizations currently exist in the region that provide transportation services to persons with disabilities, senior citizens, Medicare or Medicaid-eligible individuals and veterans. These Organizations are restricted by capacity limitations and eligibility requirements, leaving segments of the population without access to transportation. Approximately 17 organizations/companies were identified in the region as providing some type of transportation. These organizations include agencies such as Senior Services and Councils on Aging, Veteran Affairs, Job and Family Services,

K&P Medical, cab companies, hospitals, Henry County Transportation Network, Triangular Processing and non-profit organizations. Many of the transportation-providing organizations provide services mostly during the week and during daytime hours, however, there are a few that provide service on the weekend and during the evenings.

2. COMMUNITY TRANSPORTATION NEEDS

- a. Transportation for individuals who do not otherwise qualify under current programs
- b. Extended hours of transportation
- c. Transportation on weekends
- d. Education on transportation programs and providers
- e. Transportation for individuals being transferred to an inpatient facility for mental health
- f. Additional emergency medical transportation resources
- g. Better coordination of existing services
- h. Resources and funding for transportation services
- i. Accessible transportation options i.e., wheelchair
- j. Active transportation options i.e., biking, walking, etc.

3. PLAN FOR ACHIEVING SHARED GOALS

Fundamental to the Coordinated Transportation Plan process is the active and meaningful involvement of stakeholders. For projects selected for funding under the Section 5310 and 5311 programs, participation in planning activities must include participation and/or representation of the following, at minimum:

1. Seniors;
2. Individuals with disabilities;
3. People with low incomes;
4. Public, private and non-profit transportation providers;
5. Human services providers and;
6. The general public.

To ensure participation from the above groups the following stakeholder involvement activities were performed:

- a. A public Transportation Needs Survey was conducted in collaboration with Bowling Green State University's Master of Public Administration students between February 28 and March 31, 2024, which received a total of 210 responses from residents of the region;
- b. The Transportation Coordination Committee met quarterly for a total of four times, all meetings were open to the public and meeting minutes were recorded;
- c. A Stakeholder Survey was conducted during the month of April 2024 which received a total of 19 responses from members of the Transportation Coordination Committee;
- d. A Provider Information Form was completed by 6 providers in the region;
- e. A public meeting was held in April 2024 to discuss the purpose and answer the public's questions regarding the project;

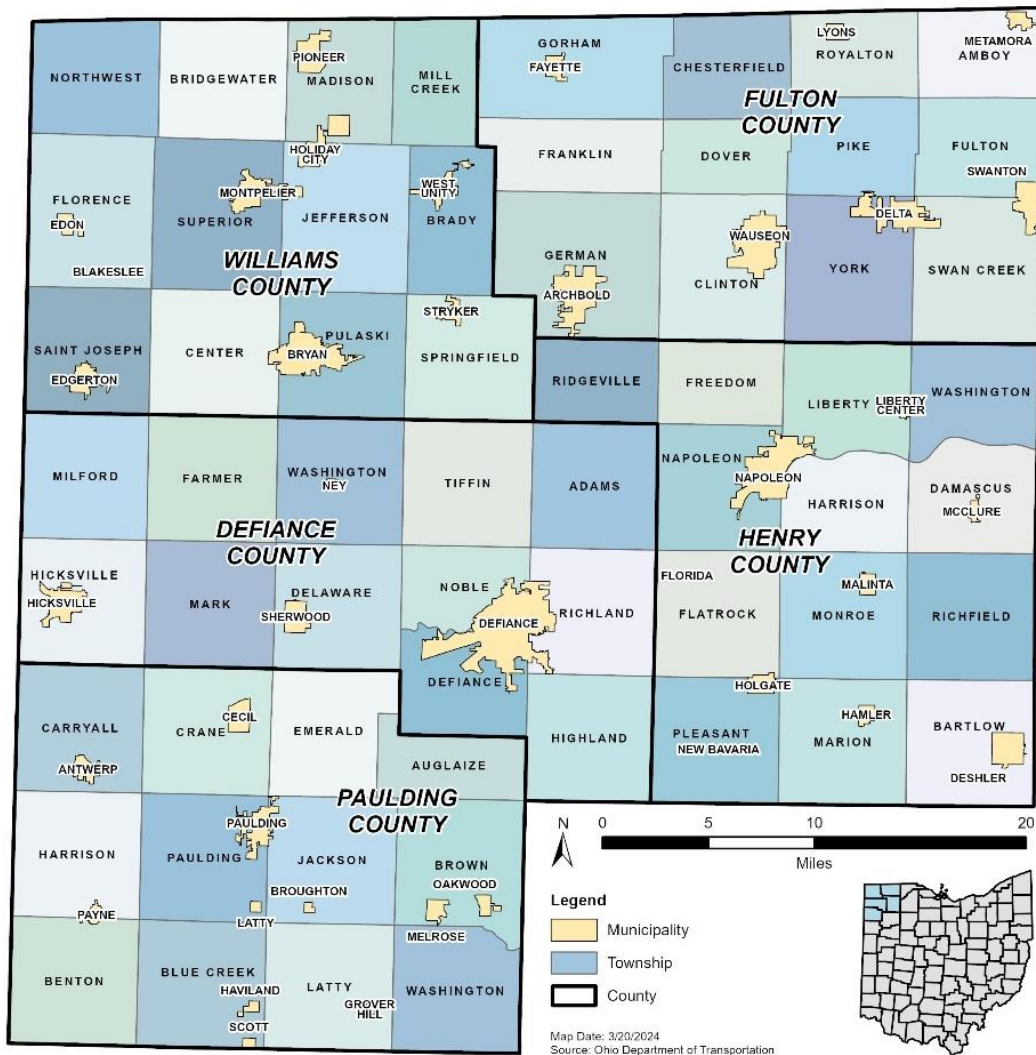
- f. A public comment period was open in May 2024 to propose the new Coordinated Transportation Plan and receive additional input on transportation needs in the region;
- g. Participation in county meetings such as Safe Communities, POWER, Long-Range Transportation Plan, Access to Healthcare, etc.

This plan was developed and adopted by the Five-County Transportation Coordination Committee. More information about the committee can be found in Appendix A.

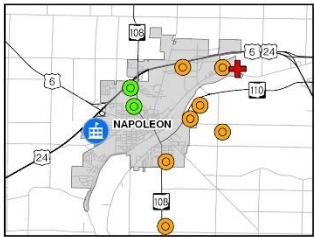
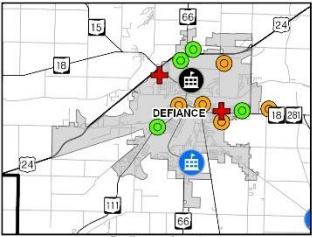
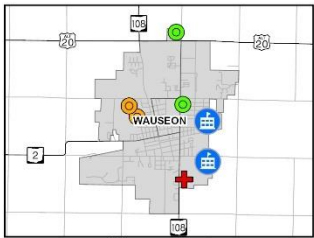
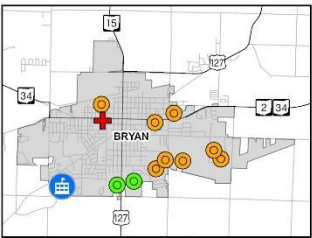
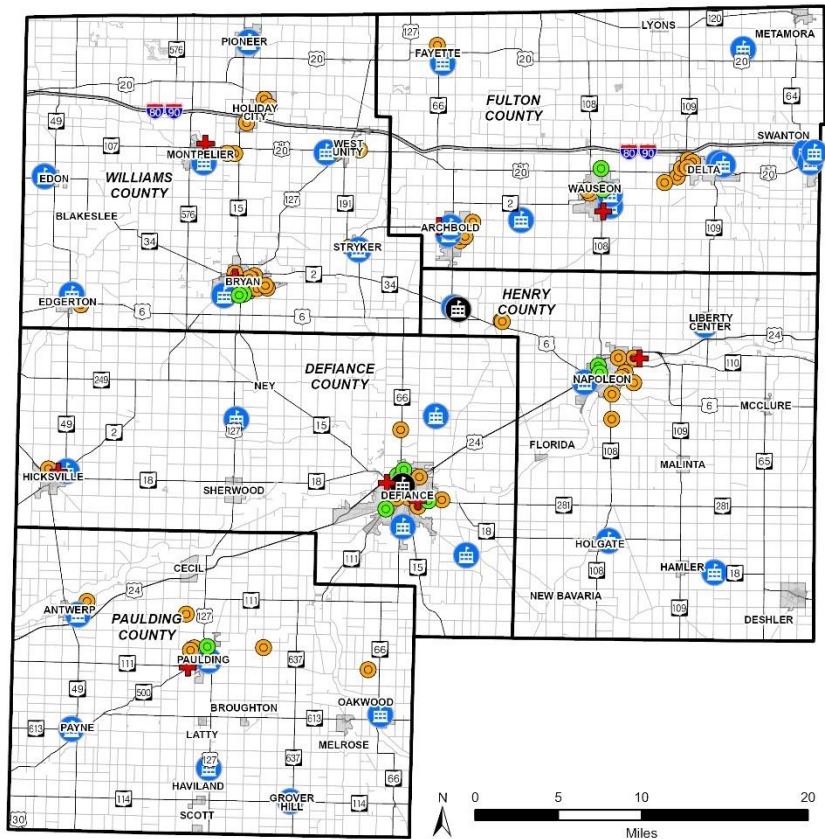
I. Geographic Area

Defiance, Fulton, Henry, Paulding, and Williams counties are located in Northwest Ohio, bordering the States of Indiana and Michigan, along with Ohio counties of Putnam, Wood and Lucas, an area once known as The Great Black Swamp. According to data.census.gov, the five-county area is approximately 2,072.8 square miles of land. The region has 4 cities: Bryan, Defiance, Napoleon and Wauseon, which are all the county seats. Within the region there are 61 townships, 35 villages and 8 Census Designated Places (CDPs). Map 1 below shows the geographic area of the five-county region.

Map 1: Basic map of the geographic area covered by the plan

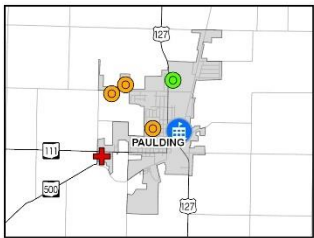


Map 2: Major Trip Generators in the Geographic Area

II. Population Demographics

The total population of the 5-county region is 164,303 people. Each county's population is projected to decrease slightly over the next twenty-five years as shown in *Chart 1*. As seen in the chart, the population of the region is projected to decrease from 164,303 in 2022 to 139,581 in 2050.

In addition to decreasing, the region's population is also aging. There are 42,943 people who are 60 or above, 26% of the population (see *Chart 2*). It is likely that the 60 and older population will continue to grow as the population ages. With the aging population comes the discussion of transportation services for seniors, as many individuals become unable to drive themselves as they age. Those who do not have family members who can transport them are left to rely on services such as those provided by the senior centers. The need for this type of transportation is only going to increase with time. It is important that the needs of these individuals be addressed. A coordinated transportation system could greatly benefit those seniors as it would provide cost and trip efficiencies allowing for expanded services.

According to 2022 ACS data, there are 24,453 individuals with a disability in the region, which comprises 14.9% of the total population as shown in *Chart 4*. *Chart 4* also demonstrates the various age groups with a disability, showing that 58.3% of individuals 18 to 64 years have a disability, the largest percentage of all age groups in the region to have a disability. These disabilities include hearing, vision, cognitive, ambulatory and self-care, all of which might prevent an individual from having the ability to drive.

One of the most overarching and difficult issues to address when addressing the lack of transportation is poverty. The Ohio Association of Community Action Agencies’ 2019 State of Poverty Report¹ provides an in-depth, data-based look at the realities of poverty in Ohio. Poverty is a challenge for several reasons:

- Many people who experience barriers to transportation (age, health, disability) that are currently met by existing services (senior services, Medicare, Board of Developmental Disabilities) also experience poverty; but the opposite is not necessarily true. Many people who experience poverty do not necessarily experience those other barriers that might qualify them for existing transportation services.
- The episodic poverty rate in the United States (32%) is twice as high as the official annual poverty rate (16%) and eight out of every nine Americans who have lived in poverty experience it only short term.² For this reason, it can be hard to figure out who needs help and how to best help them at the time they most need it.
- Poverty can be caused by a wide variety of issues or occurrences ranging from something as serious as imprisonment to something as seemingly innocuous as a car breaking down which makes the issue extremely difficult to isolate and address.

As shown in *Chart 5*, 43,993 households had 12-month incomes that were below the poverty level. *Chart 6* shows that 9.8% of all individuals in the region had income below the poverty level, while 90.2% had incomes at or above the poverty level.

The Maumee Valley Planning Organization (MVPO) revealed that public transportation was a major community concern through the process of developing their “Moving Together 2050” Long-Range Transportation Plan. In 2023, MVPO made available a transportation opinion survey to gather public input about the region’s current transportation system. A total of 121 surveys were collected from August 1- October 3, 2023. In a survey question asking respondents to rank their top three priorities for transportation, improving safety for pedestrians, improving roadway safety, and maintaining the transportation system in a state of good repair were the top three.

III. Assessment of Available Services

Conducting an evaluation of service provider capabilities and analyzing the existing gaps and duplications of services for transportation resources in each community, provides transportation planners with the information needed to implement changes that will improve the network of transportation resources and services in Defiance, Fulton, Henry, Paulding, and Williams counties and across county lines.

Maumee Valley Planning Organization and Northwest Ohio Mobility identified stakeholders to participate in the assessment of available services. These stakeholders included those who were represented in the current or past planning committees, as well as others who the planning committee identified as being appropriate stakeholders. Surveys were sent out to each of the identified stakeholders. The purpose of the survey was to offer the stakeholders an opportunity to discuss the specific transportation services, gaps, needs, and priorities for their respective service areas or communities.

When applicable, information reported in the previous coordinated plan was used to supplement information gathered during this planning effort.

IV. Assessment of Transportation Needs and Gaps

In an effort to better understand the needs of the Northwest Ohio region, the planning committee examined research and data, as well as solicited input from the community, with the help of Bowling Green State University Master of Public Administration students, in an effort to gather information about needs and gaps in transportation services.

The demographic and socio-economic conditions of the study area are discussed in the Demographics section of this plan. The following overview is an evaluation of the gaps in service based upon geographic data as well as from the perspective of the targeted populations, transportation providers, and the general public.

Maumee Valley Planning Organization asked a variety of stakeholders in the area to solicit input and request participation from any organization that could potentially be impacted by the coordinated transportation planning process. More information on how the lead agency engaged stakeholders and the general public is available upon request.

The following methods were used to assess transportation needs and gaps:

1. Assessment of data and demographics
2. Surveyed transportation providers, stakeholders, and riders on needs and gaps
3. Held transportation coordination committee meetings and county meetings, both open to the public, to solicit feedback and input
4. Held a public comment period for proposed coordinated plan

Local Demographic and Socio-Economic Data

Data for each target population group were aggregated by Census Block Group for transportation analysis. The demographic and socio-economic data is valuable because a comparison of where the highest and lowest densities of individuals who are most likely to need transportation live. This information can then be compared to the locations of (1) major trip generators, and (2) available transportation services.

Exhibit 1 illustrates the percentage of the population being older adults (age 65 and older). The highest percentage in the region is attributed to a small portion of the City of Bryan (> 50%) and parts of Paulding County also have a higher proportion compared to other areas in the region.

Exhibit 1: Map of Population Density of Individuals Age 65 and Older

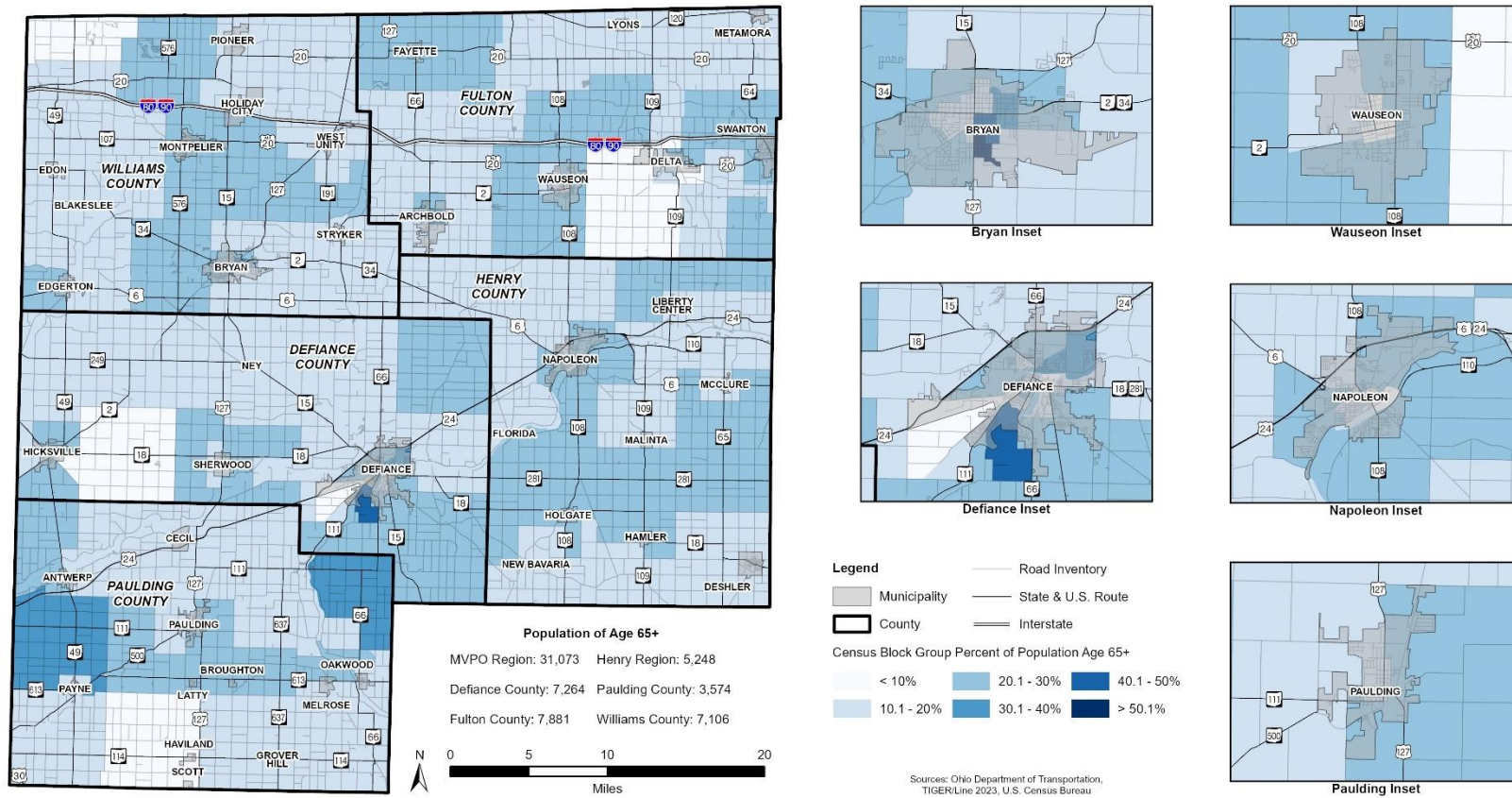


Exhibit 2 indicates the areas with the highest percentage of households without a vehicle. The absence of a vehicle in the household is often an indication of the need for transportation services. Notable areas of concern are western Defiance County and central Paulding County.

Exhibit 2: Map of Density of Zero Vehicle Households

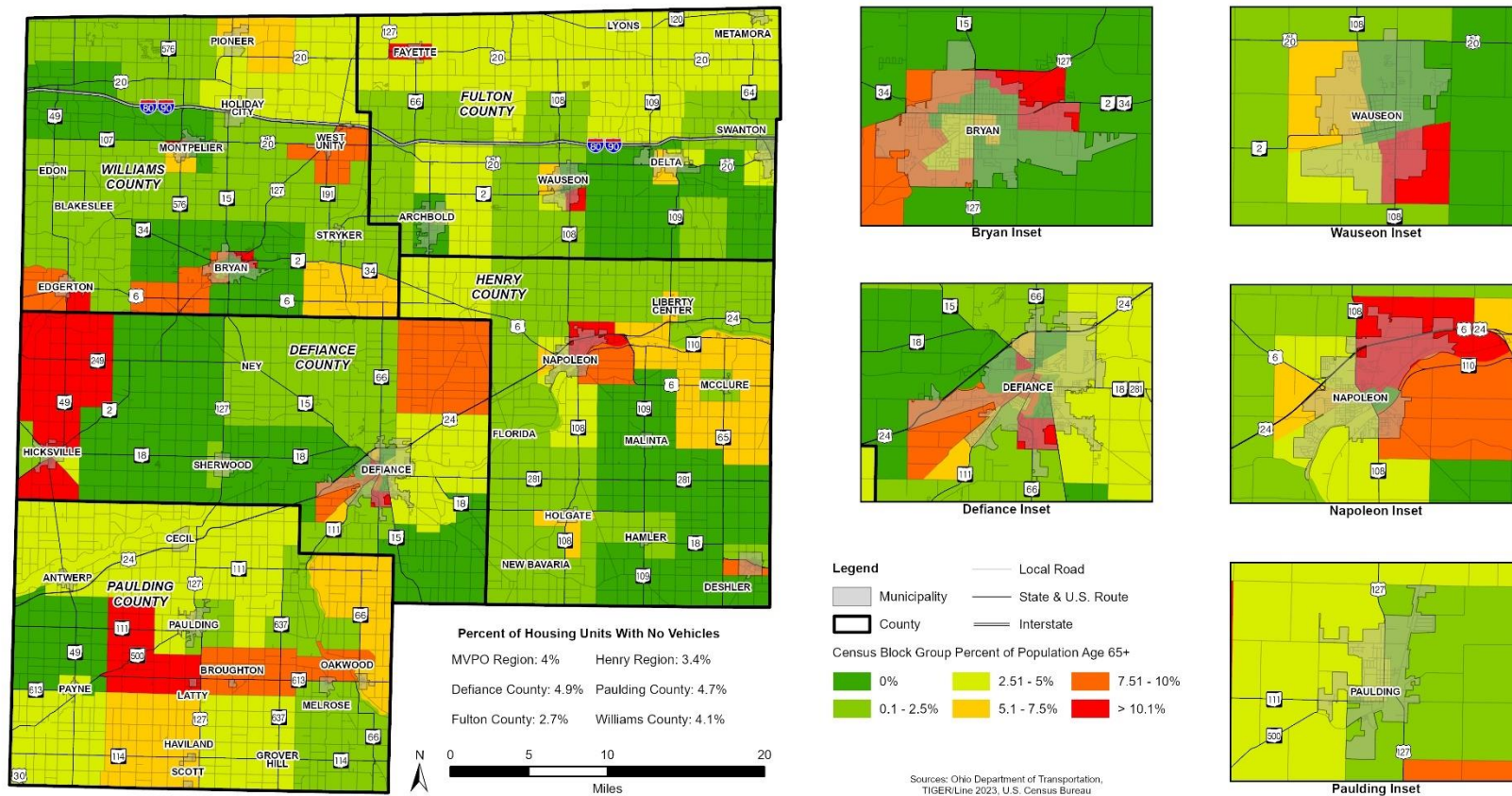
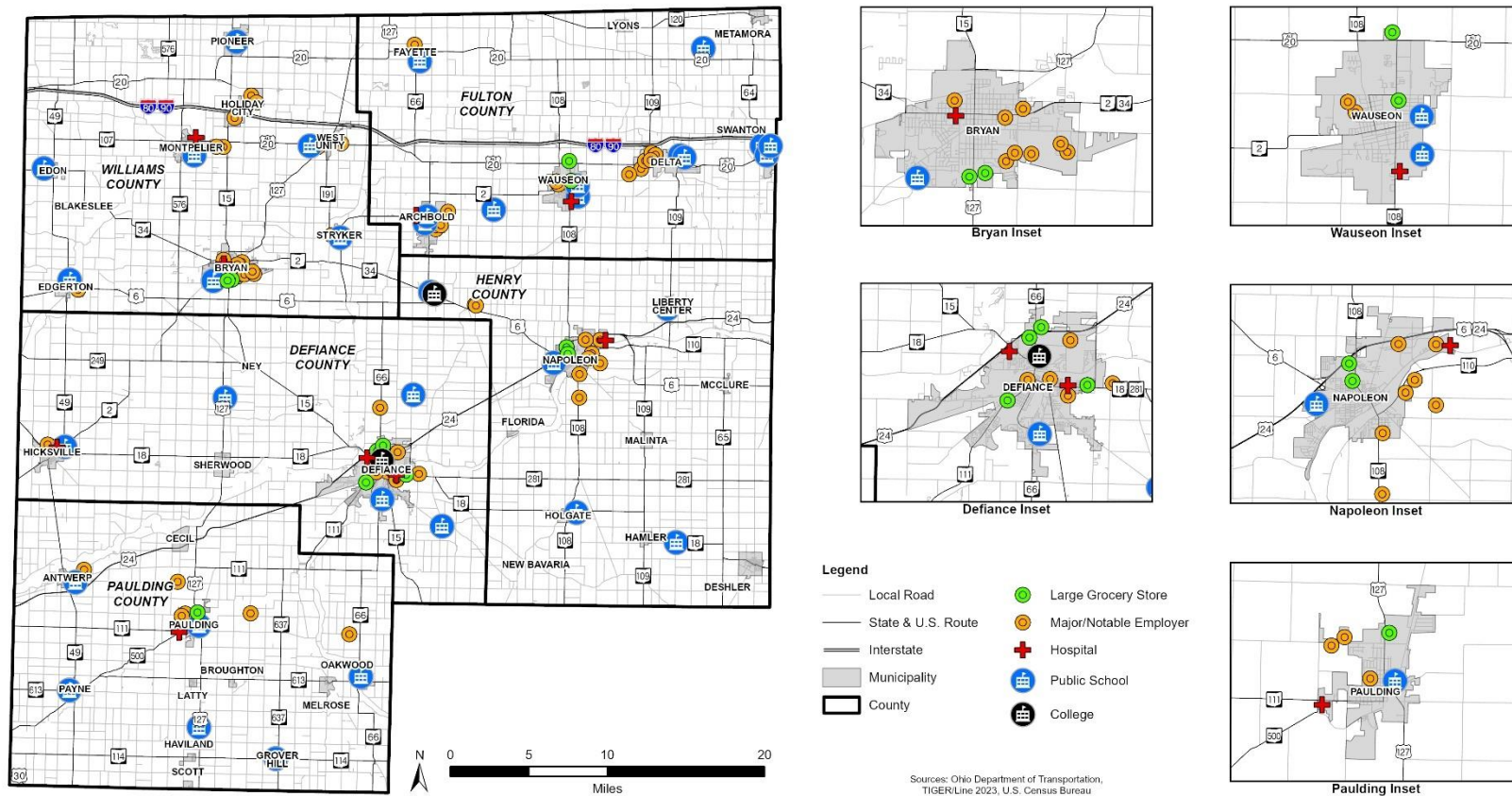


Exhibit 3 shows the top destination locations for the existing transportation providers and major trip generators for anyone in the area, including those who drive a personal vehicle. Major trip generators include schools, hospitals, large grocery stores, and notable employers. These are traditionally most common in larger towns and cities.

General Public and Stakeholder Meetings/Focus Groups

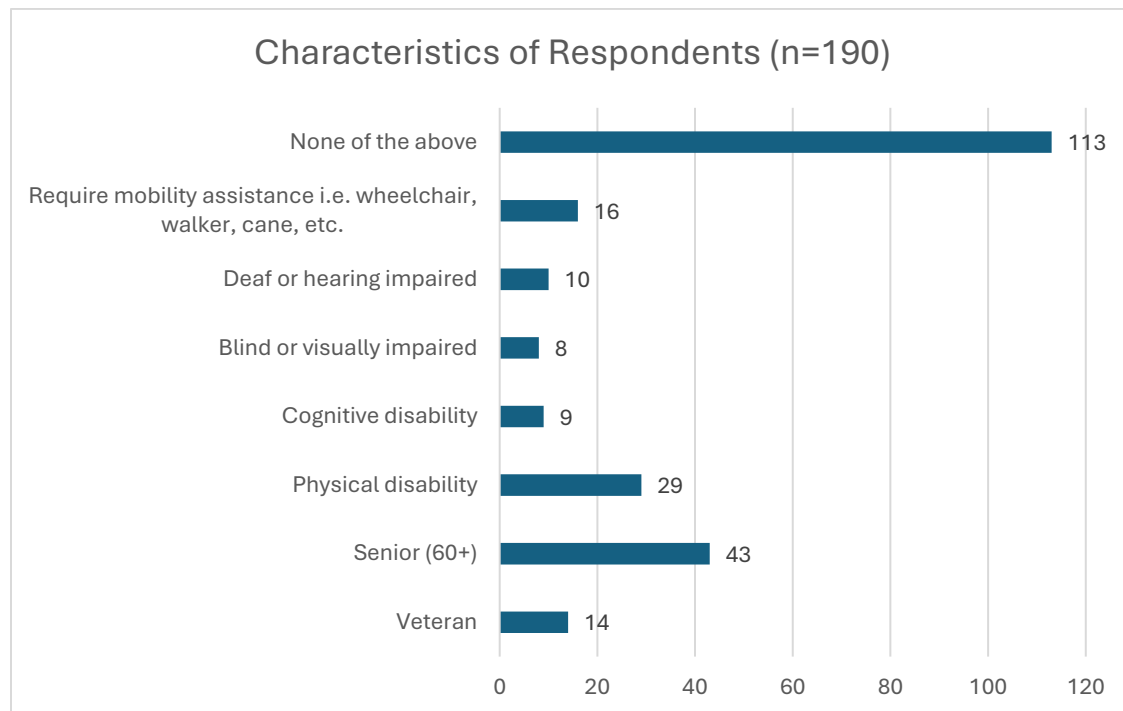
Maumee Valley Planning Organization and Northwest Ohio Mobility hosted and facilitated 11 local meetings and focus groups to discuss the unmet transportation needs and gaps in mobility and transportation. Approximately 80 people participated in the meetings. Of those, 0 self-identified as older adults and 0 self-identified as being a person with a disability, though older adults and people with disabilities have been invited to participate. More information about what meetings were held and attendance at those meetings is available upon request.

During the meeting, the Maumee Valley Planning Organization and Northwest Ohio Mobility presented highlights of historical coordinated transportation in the Northwest Ohio region, and discussed the activities since the last Coordinated Public Transit Human Services Transportation Plan that have helped to address some of the unmet transportation needs and gaps in services for the area.

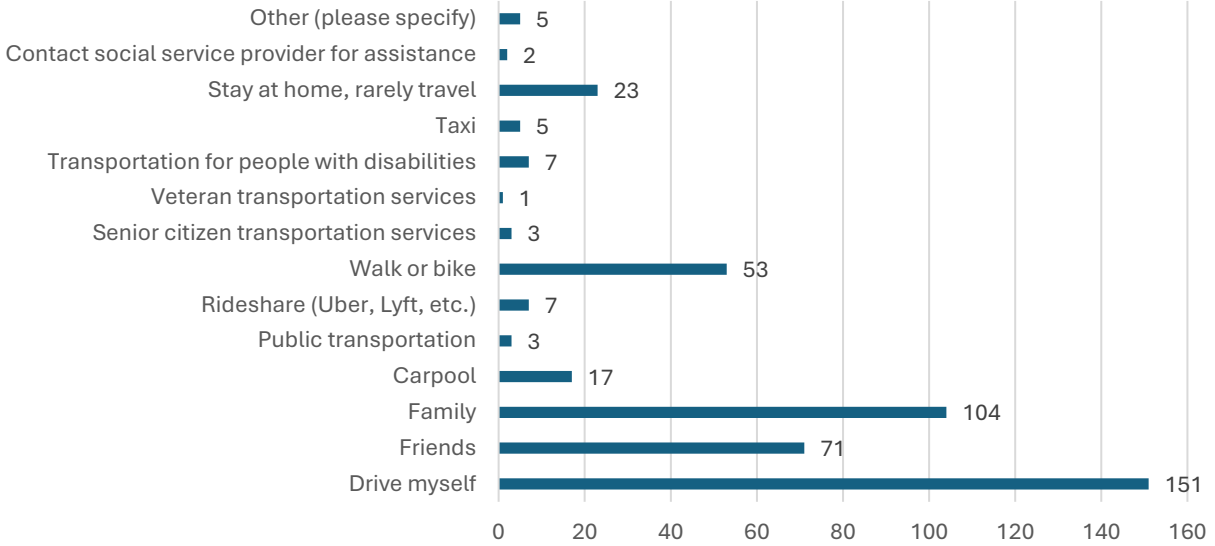
Participants discussed more than 5 mobility issues to achieve, preserve, avoid, or eliminate through coordination during the meetings. Coordinated transportation stakeholders will consider these unmet needs when developing transportation goals and strategies, and grant applications. The exhibit at the end of this section provides a summary of the unmet mobility needs discussed during the meeting as well as the needs identified by the survey results.

Surveys

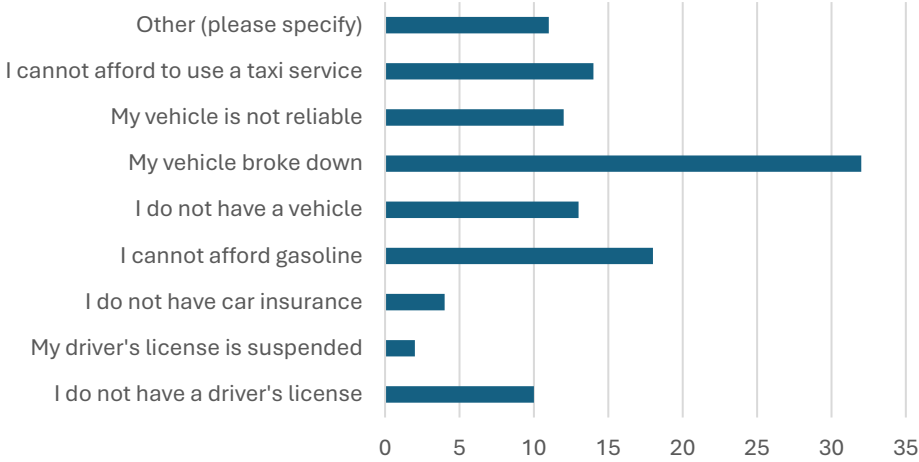
The following survey summary includes the information gained from the 210 surveys from the **general public**: 7% of the respondents are Veterans, 23% are older adults, 15% have a physical disability, 8% require mobility assistance, 5% have a cognitive disability, are deaf, or are hard of hearing, and 4% are blind or visually impaired.



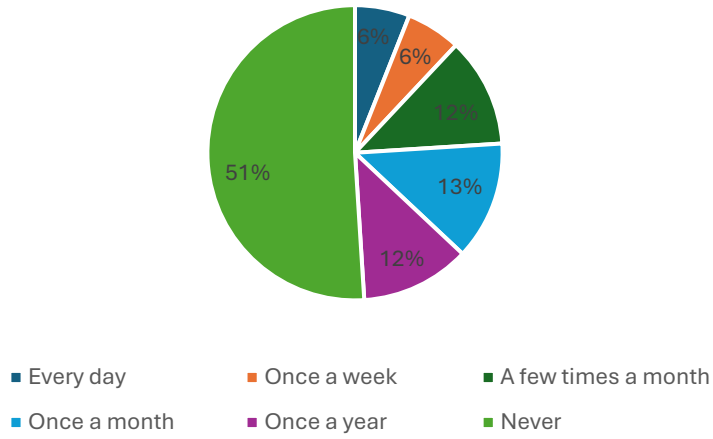
In the last 6 months, what ways did you travel? (n=172)



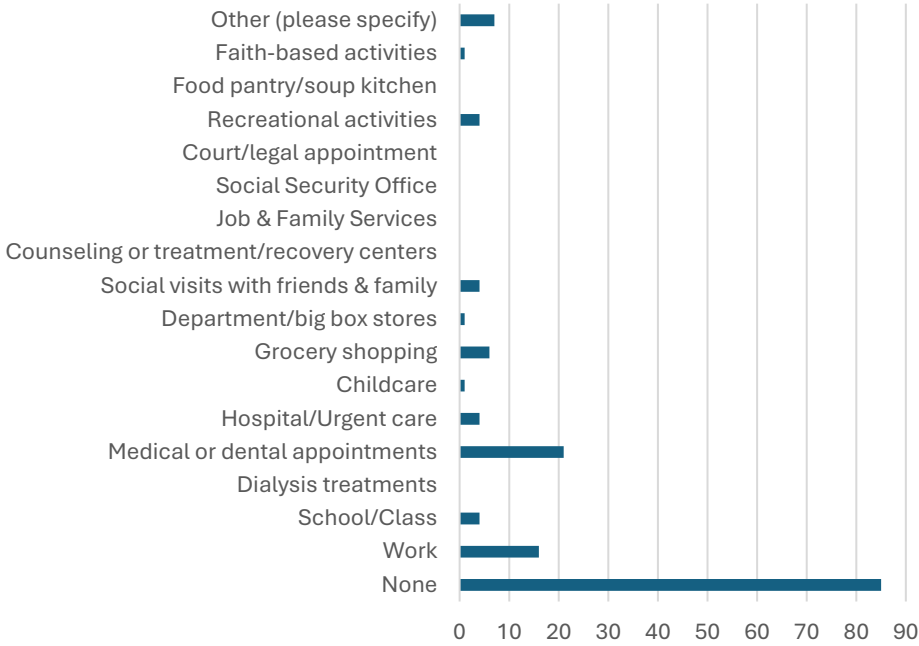
Barriers to Mobility (n=172)

Challenges to Coordinated Transportation

In addition to identifying needs, the planning committee gathered information from stakeholders and used their own professional experience to identify challenges to providing coordinated transportation services. These challenges include the following:

1. Concerns that the Coordinated Transportation Plan will harm for-profit transportation businesses in the region.
2. The region will become dependent on grant funding for transportation solutions then have the funds removed.
3. Addressing actual need versus perceived need.
4. Finding funding for transportation.
5. Losing quality of service for population currently served.
6. Addressing the unmet needs that pertain to each county - do not address them as a whole if it does not pertain to specific counties.
7. General transportation - our area is very small and has limited resources for individuals just needing to get out. Provide transportation for reasons other than non-emergency medical appointments.
8. Differing political views and power structure.
9. Long wait times for individuals who are sick or older.

Summary of Unmet Mobility Needs

The following table describes the identified unmet transportation needs that were identified and the method used to identify and prioritize each need. Needs are listed in order of their rank in highest to lowest priority.

V. Goals and Strategies

Developing Strategies to Address Gaps and Needs

Strategies for improving transportation for Defiance, Fulton, Henry, Paulding, & Williams counties should address the service gaps and user needs identified in this plan, if they are to be effective. As described, the gaps and unmet needs were based on information obtained from geographic analysis, the attendees participating in the meetings, and responses to the public survey.

Based on information gathered throughout the planning process, Maumee Valley Planning Organization developed the following strategies to address the gaps and unmet transportation needs. Priority levels are assigned by considering the primary funding sources that could be available to support plan implementation compared to the importance of meeting this unmet need expressed by the public and stakeholders. Not all strategies are activities specifically eligible for funding under the existing programs, nor is it guaranteed that sufficient funding will be available to achieve every strategy identified. In addition, the local stakeholders will need to provide support and commit to pursuing the strategies if they are to be accomplished. Nonetheless, these strategies have been tailored to the identified primary gaps and needs.

Below is an outline describing the prioritized strategies to address each of the identified unmet transportation needs and gaps in service.

Goal #1: Efficient utilization of resources

Improve effectiveness, reduce per unit costs, and expand services while maintaining human centered design.

Need(s) Being Addressed: The need being addressed is the expansion of public transportation in our region.

Strategy 1.1: Create working committees within the TCC to research efficiencies, while keeping riders' experiences central to decision making.

Timeline for Implementation: Working committees will be created within one-year of coordinated plan being approved.

Action Steps:

1. Identify what working committees will be created
2. Identify goals and objectives for committees
3. Assign committee members to committees
4. Hold regular committee meetings

3. Identify resource generating opportunities
4. Identify collaboration opportunities
5. Increase resources and capacity within the region (vehicles, technology, vehicle repair programs, and revenue streams)

Goal #2: Seek regional transportation cooperation

Partners make connections, informal agreements, and share resources.

Need(s) Being Addressed: This goal addresses the need for better coordination of existing services, education on transportation programs and providers and retaining the mobility program

Strategy 2.1: Transportation Coordination Committee will work with Mobility Manager to develop strategies on how to expand transportation services in the region and fill gaps of unmet needs.

Timeline for Implementation: Ongoing

Action Steps:

1. Hold quarterly TCC meetings
2. Update provider information annually
3. Maintain a Mobility Manager
4. Develop programs in which stakeholders partner to create solutions for unmet needs
5. Support economic development and workforce development

Goal #3: Transportation education

Educate stakeholders and the public on transportation programs and provider services.

Need(s) Being Addressed: This goal addresses the need for education within the community about the transportation services available.

Strategy 3.1: Mobility Manager creates and distributes education around transportation providers and programs within the Northwest Ohio region.

Timeline for Implementation: Ongoing

Action Steps:

1. Public survey and meetings
2. Individual interviews with riders
3. Attend community events and meetings
4. Produce quarterly newsletters
5. Electronic education via website and social media

Resources Needed: Staff time website, marketing costs

Goal #4: Active transportation

Improve active transportation in the region.

Need(s) Being Addressed: This goal addresses the need for active transportation such as walking and biking.

Strategy 4.1: Mobility Manager will sit on Active Transportation and RTPO committees to ensure mobility is represented and accounted for.

Timeline for Implementation: Ongoing

Action Steps:

1. Mobility Manager attend RTPO and Active Transportation meetings
2. Update any county Active Transportation plans when needed
3. Ensure trails remain ADA compliant

Parties Responsible for Leading Implementation: Mobility Manager

Parties Responsible for Supporting Implementation: Transportation Coordination Committee and Maumee Valley Planning Organization's transportation planners

Resources Needed: Staff time

Potential Cost Range: \$5,000-\$10,000

1. Measure: Number of RTPO meetings per year
 - a. Target: Minimum of 20 bi-weekly RTPO meetings per year

3. Measure: Number of trails that continue to be ADA compliant
 - a. Target: 100% of trails continue to be ADA compliant

VI. Plan Adoption

To adopt the Coordinated Transportation Plan, an agreement of the majority of the Transportation Coordination Committee is needed, along with an affirmative vote of the majority of the Maumee Valley Planning Organization Executive Council. The 2024-2028 Coordinated Transportation Plan was adopted on June 10, 2024 by a majority of the Executive Council, and was approved by the Transportation Coordinated Committee on April 24, 2024. Public input was sought and received prior to the official adoption of the Plan through public notices in local newspapers, social media, human service agencies in the area, and word of mouth.

The Coordinated Transportation Plan will undergo annual reviews, with amendments being made as needed and a full plan update will be completed every 4 years.

WHEREAS, the MVPO Transportation Coordination Committee has approved the Coordinated Plan which combines Defiance, Fulton, Henry, Paulding, and Williams counties to cooperate in transportation efforts and four goals; and

NOW, THEREFORE, be it resolved by the Executive Council of the Maumee Valley Planning Organization:


Section 1. Approval. The Executive Council of the Maumee Valley Planning Organization hereby approves the Defiance, Fulton, Henry, Paulding, and Williams County, Ohio Coordinated Transportation Plan 2024-2028.

Annual Reviews

April 23, 2025 – All goals and strategies were discussed at the annual review meeting. The committee agreed to keep all goals and strategies the same, except adding “vehicle repair programs” to Strategy 1.2, Section v. as an example of increasing resources and capacity in the region. The only other update to the Coordinated Transportation Plan was contacts that may have changed. For such small changes, we did not obtain an updated Resolution.

Amendments

No amendments were made prior to the 2025 Annual Review.

Appendix C: Definitions

There are several terms used throughout the plan that may be unique to transportation providers or human service agencies. The terms are defined here for reference.

Coordination – Collaborative efforts toward understanding and meeting the mobility needs in the most appropriate, cost effective, and responsive manner.

FAST Act – Congress established the funding for Federal Transit Administration programs through authorizing legislation that amends Chapter 53 of Title 49 of the U.S. Code. On December 4, 2015, President Obama signed the Fixing America’s Surface Transportation (FAST) Act, reauthorizing surface transportation programs through Fiscal Year 2020.

Gaps in Service – A break in the continuity of available transportation resources such as a break between hours of operation or a break between two or more geographic areas.

Lead Agency – The organization responsible for facilitating outreach; composing a plan that meets the requirements of current Federal and State legislation; maintaining documentation from the planning process and making it available upon request; and leading stakeholders through annual reviews, amendments, and updates of the plan. The Lead Agency also is responsible for submitting the adopted Coordinated Plan and all amendments or updates to participating stakeholders and ODOT.

Planning Committee – (indicate if the planning committee has another formal name) The Planning Committee is composed of key community stakeholders. The Planning Committee members agree to actively participate in the planning process and act as the plan advisory and adopting entity.

Ridership – The total number of passengers who boarded transportation vehicles are counted each time they board a vehicle.

Section 5310 Program – Enhanced Mobility of Seniors & Individuals with Disabilities (49 U.S.C. 5310) provides Federal formula funding for the purpose of assisting private nonprofit groups in meeting the transportation needs of older adults and people with disabilities when the transportation service provided is unavailable, insufficient, or inappropriate to meeting these needs. The program aims to improve mobility for seniors and individuals with disabilities by removing barriers to transportation service and expanding transportation mobility options.

Section 5311 Program – The Formula Grants for Rural Areas program provides capital, planning, and operating assistance to states to support public transportation in rural areas with populations of less than 50,000 where many residents often rely on public transit to reach their destinations. The program also provides funding for state and national training and technical assistance through the Rural Transportation Assistance Program. Subrecipients may include state or local government authorities, nonprofit organizations, and operators of public transportation or intercity bus service.

Section 5307 Program – The Urbanized Area Formula Grants program (49 U.S.C. 5307) makes federal resources available to urbanized areas and to governors for transit capital and operating

assistance in urbanized areas and for transportation-related planning. An urbanized area is an incorporated area with a population of 50,000 or more.

Transportation – Transportation is broadly defined to include traditional transit, human service agency services, on-demand (taxi-like) services, bicycle and pedestrian programs and amenities.

Unmet Transportation Needs – Transportation that is wanted or desired but is not currently available.
