#### Provider Updates

- Henry County Transportation Network, Commissioner Glenn Miller welcomes Interim Director Tom Stuckey
  - After an unexpected departure of leadership, ODOT and Tracy Busch, EMA Director, assisted with grant writing. Continuing all services as usual in Henry County
  - Expansion projects were put on hold for the year, but still interested in assisting others and looking at a regional model

#### Rider Updates

- Defiance County Board of DD, Jenna Peper
  - Discussed transportation offerings via waiver programs
  - The providers and access to transportation is still limited for going to work and social events- encouraged the committees work to increase access
  - Other participants agree that transportation for work and to reduce social isolation is a great need in our area

#### Mobility Management Updates

- Funding
  - Triangular Processing applied for 5310 funding and requested additional funding to expand services to seniors
  - Henry County Transportation Network applied for 5311 funding for county services
  - No applications were submitted to expanding to services to Defiance and Williams Counties this grant cycle
  - ODOT will be transitioning to a 2-year grant cycle for CY 24-25 (next grant cycle)
    - Office of transit used to be 25 people and is now 12 people- change is to allow staff more time to interact with programs
